1. Water and Sanitation Agency (WASA), Lahore Development Authority (LDA) (hereinafter referred to as the "Client") invites the sealed Bids from HUD & PHED approved contractors for FY-2019-20 having license from PEC in category C-4 or above with specialization in code CE-09 & CE-10, registered with FBR and PRA, for LAYING OF FORCEMAIN OF ICHRA MORE DISPOSAL LAYING OF FORCEMAIN AND REPLACEMENT OF SEWERAGE SYSTEM AT SULTAN AHMED ROAD.
2. The bidding documents are available immediately after publication (2014 PPRA Rule 25(1)) and can be obtained from the office of Director Procurement & Stores, 59-F Gulshan-e-Ravi Lahore and a complete set of Bidding Documents can be obtained on submission of written application addressed to Director Procurement & Stores along with above mentioned documents (FBR & PRA Certificate, Renewal Letter of HUD & PHED & valid PEC Licence in category C-4 or above with specialization in code CE-09 & CE-10) and payment of a non-refundable fee of Pak. Rs.4000 (Rupees Four Thousand Only). Bidding documents shall be issued to owner of the firm by showing original CNIC and / or to Authorized representative of firm having authority letter with specimen signature of representative of firm along with original CNIC.
3. Single stage two envelope bidding Procedure will be adopted. Bids (Technical & Financial) prepared in accordance with the instructions given in the Bidding Documents must be accompanied by a Bid Security 3% i.e Rs. 2,935,785/- of estimated cost in the shape of CDR. Last date for purchase of bidding documents is 21 January 2020. The Bids (Technical & Financial) must be delivered at the address given above on 22 January 2020 at 10:30 A.M. The Technical bids will be opened on the same day and the same venue at 11:00 A.M in presence of the bidders / bidders representatives who choose to participate.
4. Only technically responsive bidder will be qualified for opening of financial bid. Financial bids found technically non responsive shall be returned unopened to the bidders.
5. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal under Punjab PPRA Rule 2014 (Rule-35).
6. Conditional tender will not be accepted.
7. No tender via telegraph or by post will be accepted.
8. No tender will be issued on the date of receipt of tender.
9. The bid will be valid for the 120 days.
10. Estimated cost Rs.97,859,485.62(T.S issued vide No.DMD(E)/2339-43 dated 27-11-19)
