**SUBJECT TENDER NO. P&S/25.01/6211 - MAINTENANCE OF TUBEWELLS
INSTALLED IN (NORTH SIDE) WASA, LDA, LAHORE**

Water and Sanitation Agency (WASA), Lahore Development Authority (LDA) (hereinafter the "Employer") invites sealed bids from interested Firms / Companies / Contractors, having experience in the relevant field and registered with FBR & PRA, for MAINTENANCE OF TUBEWELLS INSTALLED IN (NORTH SIDE) WASA, LDA, LAHORE.

2. Bidding Documents (Technical and Financial Bid), containing detailed terms and conditions, etc. are available in the office of Director Procurement & Stores situated at 59-F Gulshan-e-Ravi Lahore and a complete set of Bidding Documents can be obtained on submission of written application along with payment of a non-refundable fee of Pak. Rs.5000 (Pak Rupees Five Thousand Only). Bidding documents shall be issued to owner of the firm by showing original CNIC and / or to Authorized representative of firm having authority letter with specimen signature of representative of firm along with original CNIC.
3. Single stage two envelop bidding procedure will be adopted the Bids (Technical & Financial) prepared in accordance with the instructions given in the Bidding Documents must be accompanied by a Bid Security 3% of estimated cost in shape of CDR for an amount of Rs.5,199,062/-. Last date for purchase of bidding documents is 20-01-2020. The Bids (Technical & Financial) must be delivered at the address given above on date 22-01-2020 at 11:00 A.M. The Technical bids will be opened on the same day at 11:30 AM in presence of the bidder / bidder's representatives.
4. Only technically responsive bidder will be qualified for opening of financial bid. Financial bids found technically non responsive shall be returned unopened to the bidders.
5. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal under Punjab PPRA Rules 2014 (Rule-35).
6. Conditional tender will not be accepted.
7. No tender via telegraph or by post will be accepted.
8. No tender will be issued on the date of receipt of tender.
9. Tendered rates and amount should be filled in figures as well as in words and tenders should be signed as per general directions given in the tender documents.
10. In case the total tendered amount is less than 5% (Five) of the approved estimated (DNIT) amount, the lowest bidder will have to deposit additional performance security from the Scheduled Bank ranging from 5.01% to 10%.
11. The bids will be valid for 120 days.
