Water and Sanitation Agency (WASA), Lahore Development Authority (LDA) (hereinafter the "Employer") invites sealed bids from interested Firms / Companies / Contractors, having experience in the relevant field and registered with FBR & PRA, for MAINTENANCE OF TUBEWELLS INSTALLED IN (SOUTH SIDE) WASA, LDA, LAHORE.

- Bidding Documents (Technical and Financial Bid), containing detailed terms and conditions, etc. are available in the office of Director Procurement & Stores situated at 59-F Gulshan-e-Ravi Lahore and a complete set of Bidding Documents can be obtained on submission of written application along with payment of a non-refundable fee of Pak Rs.5000 (Pak Rupees Five Thousand Only). Bidding documents shall be issued to owner of the firm by showing original CNIC and / or to Authorized representative of firm having authority letter with specimen signature of representative of firm along with original CNIC.
- Single stage two envelop bidding procedure will be adopted the Bids (Technical & Financial) prepared in accordance with the instructions given in the Bidding Documents must be accompanied by a Bid Security 3% of estimated cost in shape of CDR for an amount of Rs.3,879,840/-. Last date for purchase of bidding documents is 20-01-2020. The Bids (Technical & Financial) must be delivered at the address given above on date 22-01-2020 at 01:00 P.M. The Technical bids will be opened on the same day at 01:30 PM in presence of the bidder / bidder's representatives.
- Only technically responsive bidder will be qualified for opening of financial bid. Financial bids found technically non responsive shall be returned unopened to the bidders.
- The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal under Punjab PPRA Rules 2014 (Rule-35).
- Conditional tender will not be accepted.
- No tender via telegraph or by post will be accepted.
- No tender will be issued on the date of receipt of tender.
- Tendered rates and amount should be filled in figures as well as in words and tenders should be signed as per general directions given in the tender documents.
- In case the total tendered amount is less than 5% (Five) of the approved estimated (DNT) amount, the lowest bidder will have to deposit additional performance security from the Scheduled Bank ranging from 5.01% to 10%.
- The bids will be valid for 120 days.
