Water and Sanitation Agency (WASA), Lahore Development Authority (LDA) (hereinafter referred to as the "Client") invites the sealed Bids from WASA / HUD & PHED approved Contractors for FY-2020-21 having license from PEC in category C-6 or above with specialization in codes (CE-09 & CE-10) registered with FBR and PRA (having NTN and PNTN), for Rehabilitation Improvement of Carpet Road, Water Supply & Sewerage in Street No.4,6, & 7 Neelam Block, Allama Iqbal Town UC-219, Lahore

2. The bidding documents are available immediately after publication (2014 PPRA Rule 25(1)) at the office of the undersigned situated at 59-F Gulshan-e-Ravi Lahore, a complete set of Bidding Documents can be obtained on submission of written application along with above mentioned documents i.e (FBR & PRA Certificate, Renewal Letter of WASA / HUD & PHED & valid PEC Licence in category C-6 or above with specialization in code CE-09 & CE-10) and payment of a non-refundable fee of Pak.Rs.2000 (Pak Rupees Two Thousand Only).
3. The Bid prepared in accordance with the instructions given in the Bidding Documents must be accompanied by a Bid Security 3% of estimated cost in shape of CDR for an amount of Rs.272,524 /-. Last date for purchase of bidding documents is **8 March 2021**. The Bids must be delivered at the address given hereunder on date **9 March 2021**, at 11:00 A.M. The bids will be opened on the same day at 11:30 A.M in presence of the bidders / bidder representatives who choose to participate. Bidding documents shall be issued to owner of the firm by showing original CNIC and / or to Authorized representative of firm having authority letter with specimen signature of representative of firm along with original CNIC.
4. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal under Punjab PPRA Rule 2014 (Rule-35).
5. Conditional tender will not be accepted.
6. No tender via telegraph or by post will be accepted.
7. No tender will be issued on the date of receipt of tender.
8. Tendered rates and amount should be filled in figures as well as in words and tenders should be signed as per general directions given in the tender documents.
9. In case the total tendered amount is less than 5% (Five) of the approved estimated (DNIT) amount, the lowest bidder will have to deposit additional performance security from the Scheduled Bank ranging from 5% to 10%.
10. The tenderer shall fill up the bid schedule and indicate the percentage rate above or below the schedule of rate for "Schedule Items" on which he is willing to undertake each item of work. No premium will be quoted by the contractor against non-schedule / item rates.
11. In case, the last date of bid submission and opening falls in / within the official holidays, the last date for submission and opening of the bids shall be the next working day.
12. The bid will be valid for the 120 days.
