- Bidding will be conducted through the National Competitive Bidding (NCB) procedures as specified in the World Bank's Guidelines is open to all eligible bidders as defined in the Procurement Guidelines.
- A complete set of bidding documents will be available immediately after publication of notice and the same may be purchased by interested eligible bidders upon the submission of a written application at the address the given above by depositing nonrefundable fee of **Rs.1000 [Pak Rupees One Thousand Only]**. Interested eligible bidders may obtain further information from the office of **Director Procurement & Stores 59-F Gulshan-e-Ravi Lahore**. Bidding documents shall be issued to owner of the firm by showing original CNIC and / or to Authorized representative of firm having authority letter with specimen signature of representative of firm along with original CNIC.
- The last date for purchase of bidding document will be **21-06-2019**. Bids shall be valid for a period of **(60-days)** after Bid opening and must be accompanied by security of **2%** of the estimated price in the shape of CDR. The bid in accordance with the instructions of bidding documents shall be delivered to **O/o Director P&S, 59-F Gulshan-e-Ravi Lahore** on or before **time 10:00 A.M, 25-06-2019**. The bids will be opened on the same day and same venue at **10:30 A.M** in the presence of the bidders who choose to present. The bidder shall submit two copies of bid (Hard and Soft) clearly mention as "ORIGINAL" and "COPY" as appropriate. In the event of discrepancy between them, the "ORIGINAL" shall prevail.
- All bidders shall be required to submit with their bids, qualification information specified in the bidding documents. This information shall be used to establish through post-qualification whether the bidder is qualified to perform the work.
- Bids are required to be submitted on **item rate basis (not on the basis of Composite Schedule of Rate with percentage premium)** and the rates and amounts (in Pak Rupees) must be filled by the bidder in figure as well as in words for each item in the Bill of Quantities (Bid Schedule) and provide a total price. Non-compliance may result in rejection of bid.
- Bidders should give their best and final price in their bids as no negotiations will be allowed.
- As provided in the bidding documents, bidders engaged in corrupt or fraudulent practices (including collusion/pooling) will be declared ineligible, either in indefinitely or for a stated period of time, to be awarded a contract financed by the World Bank.
- The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.
- In case the total tendered amount is less than **5% (Five)** of the approved estimated (DNIT) amount, the lowest bidder will have to deposit additional performance security from the Scheduled Bank ranging from **5.01% to 10%**.
