- 5. A certificate that the firm and any of its JV members(s) or sub-consultant are NOT currently blacklisted or under litigation by any Government/ Autonomous Body. Neither the consulting firm nor the JV member or sub-consultant has ever been convicted of an integrity-related offense or crime related to theft, corruption, fraud, collusion or coercion.

The primary goal of Aab-e-Pak Authority is to provide safe & clean drinking water to more than 70 million populations in 36 districts of Punjab province mainly in rural, semi-urban and Peri-Urban areas. The project namely "provision of Safe & Clean drinking Water to the People of Punjab" will ensure supply of clean drinking water to a projected population of more than 100 million people till 2040. The design life of the proposed project is 20 years and shall be executed through EPC Mode. The project may include but not limited to construction of Bottled Water Plants, Ultra Filtration Plants, Reverse Osmosis Plant, Hand Pumps, Direct Water Supply, Solar Power UF Plants, Conventional Surface Water Treatment Plants, Rapid sand filtration plants, Water Kiosk (Markaz-e-Aab) etc.

The Punjab Aab-e-Pak Authority, Govt. of the Punjab, in charge of the implementation of the Project, intends to hire the services of **Owner's Engineer/ Project Management Consultant** (PMC) for Design Review & Vetting, Top Supervision and Project Management Support of the project "**Provision of Safe & Clean drinking Water to the People of Punjab**" going to be executed in **three different zones of Punjab Province i.e. North, Central & South Zone.** (**North Zone:** Rawalpindi Division, Sargodha Division, Gujranwala Division; **Central Zone:** Lahore Division, Faisalabad Division, Sahiwal Division; **South Zone:** DG Khan Division, Bahawalpur Division, Multan Division)
