REPLACEMENT OF MEDIA OF ALREADY INSTALLED 24-NO WATER FILTRATION PLANTS) ARSENIC & BIOLOGICAL CONTAMINATION REMOVAL (ULTRAFILTRATION TECHNOLOGYBASED) (4000 LTR/HR)

1. Water and Sanitation Agency (WASA), Lahore Development Authority (LDA) (hereinafter referred to as the "Client") invites the sealed Bids from Firms / Contractors / Manufacturers / Authorized Dealers registered with FBR and PRA, for Replacement of Media of already installed 24-No Water Filtration Plants (Arsenic & Biological Contamination Removal) (Ultrafiltration Technology Based)(4000 Ltr/Hr).
2. The bidding documents are available immediately after publication (2014 PPRA Rule 25(1)) and can be obtained from the office of Director (P&S) situated at 59-F Gulshan-e-Ravi Lahore on submission of written application along with payment of a non-refundable fee of Pak. Rs.2,000 (Pak Rupees Two Thousand Only).
3. Bidding documents shall be issued to owner of the firm by showing original CNIC and / or to Authorized representative of firm having authority letter with specimen signature of representative of firm along with original CNIC.
3. Single stage two-envelope bidding Procedure will be adopted. Bids (Technical & Financial) prepared in accordance with the instructions given in the Bidding Documents must be accompanied by a Bid Security 3% i.e Rs.433,622.00 of estimated cost in the shape of CDR. Last date for purchase of bidding documents is 28th November 2019. The Bids (Technical & Financial) must be delivered at the address given above on 29th November 2019 at 10:00 A.M. The Technical bids will be opened on the same day and the same venue at 10:30 A.M in presence of the bidder's / bidders representatives who choose to participate.
4. Only technically responsive bidder will be qualified for opening of financial bid. Financial bids found technically non responsive shall be returned unopened to the bidders.
5. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal under Punjab PPRA Rules 2014 (Rule-35).
6. Conditional tender will not be accepted.
7. No tender via telegraph or by post will be accepted.
8. No tender will be issued on the date of receipt of tender.
9. Tendered rates and amount should be filled in figures as well as in words and tenders should be signed as per general directions given in the tender documents.
10. In case the total tendered amount is less than 5% (Five) of the approved estimated (DNIT) amount, the lowest bidder will have to deposit additional performance security from the Scheduled Bank ranging from 5% to 10%.
11. The bids will be valid for 120 days.
12. Estimated cost Rs.14,454,048.00 (T.S issued vide No.D(WWT)/1242-47 dated 18-10-2019)
